RDC XI Resolution No. 47, Series of 2004

Approving the Davao Regional Development Plan, 2004-2010

Whereas, In a memorandum to the regional development councils (RDCs) dated 26 July 2004, re *Planning Guidelines on the Formulation of the Medium-Term Philippine Development Plan and the Accompanying Medium-Term Public Investment Program Based on the National Development/10-Point Agenda*, the Secretary of Socio-Economic Planning directed the submission to Her Excellency President Gloria Macapagal-Arroyo by 25 November 2004 their respective regional development plans and investment programs;

Whereas, In a memorandum to the RDCs dated 6 August 2004, the NEDA issued the *Supplemental Guidelines on the Formulation of the Regional Development Plans/Investment Programs: 2005-2010*; this provided for the minimum contents, format and timetable to be followed in the preparation of the regional development plans and investment programs;

Whereas, Both of the aforementioned guidelines require the regional development plans to substantially contribute to the President's 10-point legacy objectives of creating more jobs, achieving higher economic growth and reducing the incidence of poverty;

Whereas, During its meeting held on 25 August 2004, this Council launched the preparation of the *Davao Regional Development Plan, 2004-2010*, tasking the Secretariat to initially draft and the Sectoral Committees to subsequently review and validate the plan, and submit the same for this Council's final consideration;

Whereas, The *Draft Davao Regional Development Plan, 2004-2010*, has been accordingly completed by the Secretariat and reviewed by this Council's committees on Development Administration, Economic Development, Infrastructure Development, Macroeconomy and Finance, and Social Development, and with their additional inputs, determined the same to be in accordance with the President's 10-point legacy, and Davao Region's chosen strategic direction for the indicated plan period; now, therefore, be it

Resolved, as it is hereby resolved, That this Council approve and adopt the *Davao Regional Development Plan, 2004-2010*, and hereby enjoin all regional line agencies, government-owned and -controlled corporations, state universities and colleges, government financial institutions, local government units, the business sector, and civil society to align their budgetary policies, program thrusts and investment priorities with the vision, goal, objectives, strategies and targets set in this *Plan*;

Resolved, That copies of this *Plan* be submitted to Her Excellency President Gloria Macapagal-Arroyo; and furnished the National Economic and Development Authority; all members of the Philippine Senate; all members of the House of Representatives representing Davao Region's eleven (11) congressional districts; all members of this Council and its Sectoral Committees; and all other regional line agencies, government-owned and – controlled corporations, state universities and colleges, government financial institutions and local government units in or with offices in the Davao Region.


